

STEWARDS REPORT
Bedgerebong Picnic Race Club

BEDGEREBONG RACECOURSE
Saturday 13th February 2010

Weather: Showery

Track: Slow (7)-Downgraded to Heavy (8) at 3:20pm.

Rail: True

Stewards: B.J Day (Chairman), T W Smith.

General: Due to the impending weather conditions Stewards brought forward races 2 through to 6.

RACE 1: Class A Handicap 800m

Gazero jumped away awkwardly and bumped **Usher In**. **Isestio Girl** and **Staraponawish** jumped away awkwardly. **Petalulu** slipped near the 700m and subsequently became unbalanced. **Staraponawish** blundered near the 600m. Mr. W Garland (**Yamaman (NZ)**) was fined \$200 (AR137A(5)(a)(ii) for using his whip in excess of five times prior to the 100m.

RACE 2: Maiden Plate 1100m

Biddy's Delight was slow to begin. **Bundarah Boy** jumped away awkwardly. **Bundarah Boy** hung out rounding the first turn. Trainer Mr. B Pawsey was advised that a warning would be placed on the geldings record. Near the 400m **Biddy's Delight** had to be checked when awkwardly placed on the heels of **Ultimate Clause** which shifted in when weakening. Ms. J Lindgren was reprimanded (AR 137(a)). Mr C Lundholm pleaded guilty to a charge under (AR137A(5)(a)(ii) for using his whip in excess of five times prior to the 100m. Mr. C Lundholm's license to ride in races was suspended for a period to commence on Sunday 21st February 2010 and to expire on Sunday 7th March and in addition to this Mr. C Lundholm was fined \$200.

RACE 3: Class A Handicap 1100m

Bordello Belle jumped away awkwardly, shifted in and bumped with **Clunes**. **Clunes** had to be steadied near the 50m when awkwardly placed on the heels of **Art of Survival** which shifted out.

RACE 4: Class B Handicap 1400m

Madam Tara refused to jump and subsequently took no part in the event. Trainer Mrs. D Prest was advised that the mare would be required to barrier trial to Stewards satisfaction prior to racing again. **Hussmania** jumped away awkwardly, shifted in and bumped with **East Boundandown** taking that runner

in onto **Fromage Princess** which was also taken in and as a result clipped the heels of **Regal Barista** and blundered.

RACE 5: Picnic Cup 1400m

Murodane jumped away awkwardly.

Race 6: Picnic Trophy Handicap 800m

Drysabone commenced to buck shortly after the start. Trainer Mr. G Bignell was advised that the gelding would be required to barrier trial to the stewards satisfaction prior to racing again. Mr. C Lundholm (**Sir Lara**) accidentally dropped his whip upon straightening.
