# Racing NSW Bookmaker Clerks Online License Renewals

# **User Guide**

### Introduction

In an effort to modernise the industry and to improve administrative functions, Racing NSW in conjunction with Racing Australia has progressively been introducing the ability for paper-based transactions to be completed online via the Single National System (SNS).

Consistent with this objective, we will again require Bookmakers Clerk's to renew their licence on line this season.

Those Clerks that have previously provided an email address should have received an email which provides a link to enter their User Registration account, which includes access to the online renewal portal. To commence the renewal process simply 'click' on the link provided.

The User Registration account can also be accessed via the Racing NSW website – please see the information provided on the following page under the heading "Logging in to User Registration'. Clerks that renewed their licence online over previous seasons who did not receive an email will be able to access their account in this manner.

Should you not have an email address registered please contact the Racing Australia Service Centre on 1800 954 143 to provide.

A central vision of the SNS on which many other objectives rely is the creation of a <u>unique</u> <u>identification for all industry participants</u> via a User Registration account. As your User Identification account is used to confirm your identity, it is important that a unique email address that is not used by any other licensee or owner is required. Do not use someone else's email address as information in regard to your licence or other matters of importance will increasingly be provided by this platform.

If you do not have an email address then you must create your own email address which can be completed at no cost via a range email platforms (gmail, outlook etc).

Should you have forgotten the email address used to access your User Registration account or cannot recall the password used, please see page refer to page 3 of this guide.

Now let's get started.

## Logging in to User Registration

1. Open a web browser such as Google Chrome, Internet Explorer or Mozilla FireFox and enter the following link. <u>http://userreg.racingaustralia.horse/</u>




