

Breeder/ owner of breeding horse	<b>Registration:</b> If your horse has not previously been returned, you must apply to register your horse to breed within 7 days of a decision to use it for breeding. If your horse has previously been returned, you must register your horse to breed when a return is next lodged. Registration applications must disclose the name of each owner/lessee and their share in the horse.	<b>Breeder</b> (broodmares)	Live foal: If your broodmare produces a live foal, you must lodge a Mare Return and Foal Ownership Declaration (FOD) within 30 days of birth with the Australian Stud Book. Non-compliance may result in your horse not being permitted to be registered to race in the future. No covering: If your broodmare is not covered during a	
	<b>Change of ownership:</b> If there is any change in your horse's		covering season, you must lodge a Mare Return by 15 March of that season with the Australian Stud Book.	
	ownership, you must lodge a transfer of ownership with the Australian Stud Book within 7 days of the transfer occurring.		<b>No live foal:</b> If your broodmare is covered but does not produce a live foal, you must lodge a Mare Return within 12 months of when she was last covered with the Australia Stud Book.	
	<b>Change of location:</b> If your horse changes location, you must notify the Australian Stud Book within 3 days. Exemptions may apply where your horse is being covered or foaling (7 days), receiving veterinary care (30 days) or attending a public auction (7 days).			
		<b>Breeder</b> (stallions)	<b>Standing:</b> You must lodge a Stallion Return by 30 June before the upcoming covering season with the Australian Stud Book.	
	<b>Retirement:</b> If you decide to retire your horse from breeding, you must notify the Australian Stud Book within 7 days of that decision.		<b>Service:</b> If your stallion is standing, you must lodge a Declaration of Service with the Australian Stud Book by the 15th day of the following month for every month during the	
	<b>Death:</b> If your horse dies, you must notify the Australian Stud Book within 48 hours of death.		covering season, even if he does not cover a broodmare in a particular month.	
	<b>Status update:</b> If your horse hasn't had any activity recorded with the Australian Stud Book in 12 consecutive months, you must update your horse's status/location and lodge any outstanding forms within 7 days. This obligation will be satisfied if you lodge a Mare Return each year. The Australian Stud Book will send reminders to you before the 12-month mark.
